General Non-Liability-Conditions for 'Via Mala'-Tour 26. – 30. August 2015

I agree - if applicable also on behalf of my passenger - to the following conditions without reservations:

We are in agreement that the coordinator makes a binding reservation of all overnight accommodations, meals and programs/itinerary necessary for the event. We agree to pay any cancellation charges that might occur, in accordance with Swiss law, and in case of journeys abroad with the applicable foreign laws. We are aware that the coordinator acts as mediator only and is entitled to forward our payments in connection with registration directly to the contracting parties and/or pass on our payments. The coordinator is liable for possible damage to him or those persons appointed to assist only in case of intent or gross negligence. Any further adhesion is, in all other respects, impossible. This also applies to damage that occurs during any event by any contracting parties or third parties. We expressly agree that we participate in this event at our own risk and that we will not seek compensation of any kind from the coordinator, as well as their representatives and contracting partners, in case of damage or accident. We alone carry the exclusive civil and criminal responsibility for damage and law-breaking acts caused by us. The respective driver of the vehicle is in possession of a valid driver's license. We also declare that our vehicles, at the time of participation in this event, is in safe driving condition and sufficiently insured in accordance with the motor vehicle act, traffic rules and regulations of the country in which we travel. We reserve the right to make any changes to the travel route and if necessary to cancel the event. Demands for compensation for damages occurred as a result of these changes are not possible. We exempt the coordinator from claims for compensation through third parties. In case monetary funds remain after the event has concluded, due to over-payments that occurred because of changes made to the itinerary, these funds will be refunded if they exceed CHF 20.00 to the participant.
